Re: Notice of Data Security Incident

To Whom It May Concern:

We represent Delta Dental of Virginia (“DDVA”) located in Roanoke, Virginia, and are writing to notify your office about an incident. By providing this notice, DDVA does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

1. Nature of the Data Event

On or around April 23, 2025, DDVA discovered suspicious activity associated with one email account and immediately initiated an investigation of the matter. DDVA engaged independent cybersecurity experts to assist with the process. As a result of the investigation, DDVA determined that certain emails and attachments may have been accessed and acquired without authorization between March 21, 2025 and April 23, 2025. DDVA undertook a comprehensive review of those files and upon completion of that review, learned that some of your personal information was contained within the potentially affected data. That is the reason for this notification. Please note that DDVA has no evidence of the misuse, or attempted misuse, of any potentially impacted information.

The information that could have been subject to unauthorized access includes first and last name and as well as Social Security numbers, state or federal government issued ID numbers, and Protected Health information.

2. Notice to Nebraska Residents

On or about November 21, 2025 DDVA provided written notice of this incident to approximately 140 Nebraska residents. A sample copy of the notification letter is being provided with this correspondence.

3. Other Steps Taken and To Be Taken

Upon discovering this event, DDVA moved quickly to investigate and respond to the incident, assess the security of its systems, and identify potentially affected individuals. DDVA also worked to implement additional safeguards and training to its employees. DDVA is providing access to credit monitoring services for 12 months, through TransUnion to individuals whose Social Security number or driver's license information was potentially affected by this incident, at no cost to these individuals.

I am writing to inform you about a recent data security incident that may have affected your personal information. Delta Dental of Virginia (“DDVA”) takes the privacy and security of all information within its possession very seriously. Please read this letter carefully as it contains information regarding the incident and steps that you can take to help protect your personal information.

What Happened. On or around April 23, 2025, DDVA discovered suspicious activity associated with one email account and immediately initiated an investigation of the matter. DDVA engaged independent cybersecurity experts to assist with the process. As a result of the investigation, DDVA determined that certain emails and attachments may have been accessed and acquired without authorization between March 21, 2025 and April 23, 2025. DDVA undertook a comprehensive review of those files and upon completion of that review, learned that some of your personal information was contained within the potentially affected data. That is the reason for this notification. Please note that DDVA has no evidence of the misuse, or attempted misuse, of any potentially impacted information.

What Information Was Involved. The information may have included your <<Exposed Data Elements>>.

What We Are Doing. As soon as DDVA discovered this incident we took the steps described above and implemented measures to enhance security and minimize the risk of a similar incident occurring in the future. DDVA is also offering you complimentary identity protection services through TransUnion, a leader in consumer identity protection. These services include <<Service Length>> of credit monitoring¹, dark web monitoring, a \$1 million identity fraud loss reimbursement policy, and fully managed identity theft recovery services. The deadline to enroll in these services is 90 days from the date on this letter.

What You Can Do. You can follow the recommendations on the following page to help protect your personal information. You can also enroll in the complementary services offered to you through TransUnion by using the enrollment code provided above. Also, as a precautionary measure, we recommend that you remain vigilant by reviewing your account statements and credit reports closely.

¹ To receive credit monitoring services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.

Steps You Can Take to Help Protect Your Personal Information

Review Your Account Statements and Notify Law Enforcement of Suspicious Activity: As a precautionary measure, we recommend that you remain vigilant by reviewing your account statements and credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained. You also should promptly report any fraudulent activity or any suspected incidence of identity theft to proper law enforcement authorities, your state attorney general, and/or the Federal Trade Commission (the “FTC”).

Copy of Credit Report: You may obtain a free copy of your credit report from each of the three major credit reporting agencies once every 12 months by visiting www.annualcreditreport.com, calling toll-free 1-877-322-8228, or by completing an Annual Credit Report Request Form and mailing it to Annual Credit Report Request Service, P.O. Fraud Alert: You may want to consider placing a fraud alert on your credit report. An initial fraud alert is free and will stay on your credit file for at least one year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any accounts in your name. To place a fraud alert on your credit report, contact any of the three credit reporting agencies identified above. Additional information is available at www.annualcreditreport.com.

Security Freeze: You have the right to put a security freeze on your credit file for up to one year at no cost. This will prevent new credit from being opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A security freeze is designed to prevent potential creditors from accessing your credit report without your consent. As a result, using a security freeze may interfere with or delay your ability to obtain credit. You must separately place a security freeze on your credit file with each credit reporting agency. In order to place a security freeze, you may be required to provide the consumer reporting agency with information that identifies you including your full name, Social Security number, date of birth, current and previous addresses, a copy of your state-issued identification card, and a recent utility bill, bank statement or insurance statement.

Additional Free Resources: You can obtain information from the consumer reporting agencies, the FTC, or from your respective state Attorney General about fraud alerts, security freezes, and steps you can take toward preventing identity theft. You may report suspected identity theft to local law enforcement, including to the FTC or to the Attorney General in your state.
