As you may be aware, we represent Accelerate Infrastructure Opportunities LLC (“Accelerate”) located at 7950 Legacy Drive, Suite 500, Plano, Texas 75024 and are writing to notify your office of an incident that may affect the security of certain personal information relating to three (3) Nebraska residents. By providing this notice, Accelerate does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about October 1, 2025, Accelerate identified suspicious activity within their computer network. In response, Accelerate notified law enforcement and promptly launched an investigation, with the assistance of third-party forensic and cybersecurity specialists, to determine the nature and scope of the activity. Through the investigation, Accelerate determined that an unauthorized actor accessed their network between September 28, 2025, and October 2, 2025, and that during that period of unauthorized access, certain files were accessed or copied by the unauthorized actor. Upon completion of the investigation, Accelerate undertook a thorough and time-intensive review of the files impacted to determine the information contained therein and to whom the information related. Accelerate recently completed this review and is now providing notice to individuals based on the results.

The information that could have been subject to unauthorized access includes name and Social Security number.

Notice to Nebraska Residents

On or about May 11, 2026, Accelerate provided written notice of this incident to three (3) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, Accelerate moved quickly to investigate and respond to the incident, assess the security of Accelerate systems, and identify potentially affected individuals. Accelerate is providing access to credit monitoring services for twelve (12) months, through Transunion, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

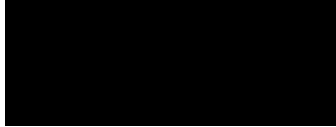
Additionally, Accelerate is providing impacted individuals with guidance on how to better protect against identity theft and fraud and is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

NOTICE OF Data Incident

Dear [REDACTED]:

Accelerate Infrastructure Opportunities LLC (“Accelerate”) is writing to inform you of a recent event that may impact the privacy of some of your information. While we are unaware of any actual misuse of your information, we are nonetheless providing you with information about the event, our response, and steps you may take to further protect your information, should you feel it appropriate to do so.

What Happened? On or about October 1, 2025, Accelerate identified suspicious activity within our computer network. In response, we notified law enforcement and promptly launched an investigation, with the assistance of third-party forensic and cybersecurity specialists, to determine the nature and scope of the activity. Through the investigation, we determined that an unauthorized actor accessed our network between September 28, 2025, and October 2, 2025, and that during that period of unauthorized access, certain files were accessed or copied by the unauthorized actor. Upon completion of the investigation, we undertook a thorough and time-intensive review of the files impacted to determine the information contained therein and to whom the information related. We recently completed this review and are now notifying individuals based on the results.

What Information Was Involved? The information contained in the impacted data included your name and the following information: Social Security number, date of birth, and health insurance information. We are not aware of any actual misuse of your information, or of your information being used to commit identity theft or fraud.

What We Are Doing. We take this incident and information security very seriously. Upon discovery, we moved quickly to investigate the incident and assess the security of our network. As part of our ongoing commitment to the privacy of information in our care, we reviewed existing security policies and procedures and are working to evaluate additional measures to further protect against similar incidents moving forward. We will also be notifying state regulators, as required. As an added precaution, we are also offering you access to twelve (12) months of complimentary credit monitoring and identity protection services through Cyberscout, a TransUnion company at no cost to you. A description of the services and instructions on how to enroll can be found within the enclosed *Steps You Can Take to Protect Personal Information*. Please note that you must complete the enrollment process yourself as we are not permitted to enroll you in these services.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next twelve (12) to twenty-four (24) months. We further encourage you to enroll in the complimentary services being provided through Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

Steps You Can Take To Protect Personal Information

Enroll in Monitoring Services

In response to the incident, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for <<service length>> months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

How do I enroll for the free services?

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED]. In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission may be reached at: 600 Pennsylvania Avenue NW, Washington, D.C. 20580; www.identitytheft.gov; 1-877-ID-THEFT (1-877-438-4338); and TTY: 1-866-653-4261. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers can obtain further information on how to file such a complaint by way of the contact information listed above. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
