Re: Notice of Cybersecurity Incident

Office of the Attorney General:

Wilson Elser Moskowitz Edelman and Dicker LLP (“Wilson Elser”) represents the City of Cedar Falls, Iowa (“the City”), located at 220 Clay Street in Cedar Falls, Iowa, and we are providing notice of a cybersecurity incident (hereinafter, the “Incident”). By providing this notice, the City does not waive any rights or defenses regarding the applicability of Nebraska law or personal jurisdiction.

This letter will serve to inform you of the nature of the Incident, what information may have been affected, and the steps that the City has taken in response to the Incident. We have also enclosed hereto a sample copy of the notice letter we recently mailed to the affected individuals on February 19, 2025.

1. Nature of the Incident

On June 19, 2024, the City’s information technology personnel detected a ransomware event on the City’s network. In response, the City engaged legal counsel and cybersecurity professionals to conduct a forensic investigation. As a credit to its security measures, the City detected and remediated the event quickly, and the unauthorized activity was limited. The event did not materially affect the City’s ability to provide public services.

The City’s forensic investigation found that the unauthorized actor may have had access to a limited number of the City’s files. Upon learning of this, the City began an extensive and comprehensive review of those files to identify and notify any individuals whose personal information was contained in those files.

2. Number of individuals and information involved.

The City’s investigation determined that the personal information of three (3) Nebraska residents may have been involved. While the information involved varies for each individual, the City’s investigation has determined that the unauthorized actor may have had access to the following categories of information: name, date of birth, Social Security number, driver’s license number, vehicle license plate number, vehicle identification number (VIN), and health information. Again,

the information involved varies for each individual, and not every category applies in each individual case.

3. Steps taken in response to the Incident.

Data privacy and security is among the City's highest priorities. Upon discovery of the Incident, the City moved quickly to investigate and respond to the Incident and assess the security of its systems. Specifically, the City engaged legal counsel and specialized cybersecurity professionals to conduct a forensic investigation to determine the nature and scope of the Incident. As a credit to the City's existing safeguards, the City was able to securely restore its network from backups, and the incident did not materially affect the City's ability to provide public services. Following the Incident, the City enhanced its network security in the following ways: changing all passwords and updating its password policy; implementing an automated patching tool; updating its firewall configurations; conducting an external penetration test; and conducting an external vulnerability scan. The City will continue to take steps to evaluate and enhance its network security.

The City mailed individual notification letters on February 19, 2025 that include an offer of complimentary credit monitoring and identity theft protection services, along with instructions on how to enroll in those services.

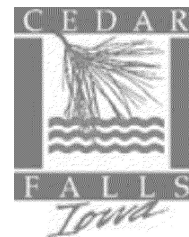

Re: NOTICE OF DATA SECURITY EVENT

Dear [REDACTED],

The City of Cedar Falls, Iowa (“the City”) is writing to inform you of a recent data security incident that may have resulted in unauthorized access to your personal information. This letter provides you with information about the incident and the steps we are taking in response, as well as resources you can use to help you protect against the potential misuse of your information.

While we do not have any evidence that anyone’s personal information has been misused for identity theft or fraud in connection with this incident, we are offering free credit monitoring and identity theft protection services and this letter includes instructions on how to enroll in those services.

What Happened?

On June 19, 2024, the City’s information technology personnel detected a ransomware event on the City’s network. In response, the City engaged legal counsel and cybersecurity professionals to conduct a forensic investigation. As a credit to our security measures, we detected and remediated the event quickly, and the unauthorized activity was limited. The event did not materially affect the City’s ability to provide public services.

The City’s forensic investigation found that the unauthorized actor may have had access to a limited number of the City’s files. Upon learning of this, the City began an extensive and comprehensive review of those files to identify and notify any individuals whose personal information was contained in those files.

What Information Was Involved?

Based on our investigation, the unauthorized actor may have had access to files containing the following categories of your personal information: Date of Birth and Driver's License Number.

The City does not have any evidence that the unauthorized actor has misused anyone’s personal information for identity theft or fraud in connection with this incident.

What We Are Doing

Data security is among the City’s highest priorities. Since the discovery of the incident, the City moved quickly to secure and strengthen its systems. The City also engaged specialized cybersecurity professionals to conduct a forensic investigation to determine the nature and scope of the Incident. The City will continue to take steps to mitigate the risk of any harm.

In light of the incident, we are also providing you with access to Single Bureau Credit Monitoring, Credit Report, and Credit Score services at no charge. These services provide you with alerts for twelve months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

While we are covering the cost of these services, you will need to complete the activation process by following the instructions below.

What You Can Do

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your credit reports for suspicious or unauthorized activity. Please review the enclosed *Steps You Can Take to Help Protect Your Information* to learn more.

We also encourage you to enroll in the credit monitoring and identity theft protection services we are making available to you at no cost.

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services:

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Steps You Can Take to Help Protect Your Information

Credit Reports: You may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the three nationwide credit reporting agencies. To order your free credit report, please visit www.annualcreditreport.com, or call toll-free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available at <https://www.consumer.ftc.gov/articles/0155-free-credit-reports>) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281.

Fraud Alerts: You can place fraud alerts with the three credit bureaus by phone or online. A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. Initial fraud alerts last for one year. Victims of identity theft can also get an extended fraud alert for seven years.

Monitoring: You should always remain vigilant for incidents of fraud and identity theft by reviewing credit card account statements and by monitoring your credit report for suspicious or unusual activity.

Security Freeze: You have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. It is free to place, lift, or remove a security freeze. You may also place a security freeze for children under the age of 16. You may obtain a free security freeze by contacting any one or more of the following national consumer reporting agencies:

File Police Report: You have the right to file or obtain a police report if you experience identity fraud. Please note that in order to file a crime report or incident report with law enforcement for identity theft, you will likely need to provide proof that you have been a victim. A police report is often required to dispute fraudulent items. You can generally report suspected incidents of identity theft to local law enforcement or to the Attorney General.

FTC and Attorneys General: You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General. For New Mexico residents, state law advises you to review personal account statements and credit reports, as applicable, to detect errors resulting from the security breach. You also have rights pursuant to the Fair Credit Reporting Act, such as the right to be told if information in your credit file has been used against you, the right to know what is in your credit file, the right to ask for your credit score, and the right to dispute incomplete or inaccurate information. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit "prescreened" offers of credit and insurance you get based on information in your credit report; and you may seek damages from violators. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
