Re: Notice of Data Security Incident

Dear Attorney General Hilgers:

Constangy, Brooks, Smith & Prophete LLP (“Constangy”) represents Renaissance Infrastructure Consulting (“RIC”), a full-service consulting firm based in Lenexa, Kansas, specializing in civil engineering, land surveying, landscape architecture, and construction phase services. The purpose of this letter is to notify you of the of the impact to Nebraska residents in accordance with Nebraska’s data breach notification statute.

1. Nature of the Security Incident

On August 11, 2025, RIC experienced a network disruption. RIC immediately took steps to secure its network and engaged cybersecurity experts to conduct an investigation. The investigation determined that an unknown actor acquired certain data without authorization on or about August 11, 2025. RIC then conducted a comprehensive review of the impacted data to determine whether personal information may have been involved. On November 5, 2025, RIC confirmed the scope of the impact and secured information sufficient to effectuate notice to impacted individuals.

Please note that RIC has no evidence of fraud or misuse of any of the data, only evidence that data was acquired without authorization.

2. Number of Affected Nebraska Residents & Information Involved

The incident involved personal information for approximately three (3) Nebraska resident(s). The information involved in the incident for the affected Nebraska resident(s) may differ depending on the individual but may have include name and Social Security number, driver’s license number, passport number, or health insurance information.

3. Notification to Affected Individual(s)

November 11, 2025

On November 11, 2025 a notification letter was sent to the affected resident(s) by USPS First Class Mail. The notification letter provides resources and steps this individual can take to help protect their information. The notification letter also offers individuals the opportunity to enroll in 12 months of complimentary identity protection services through TransUnion, including credit monitoring, dark web monitoring, \$1 million identity fraud loss reimbursement policy, and fully managed identity theft recovery services. A sample notification letter is enclosed.

4. Steps Taken Relating to the Incident

Upon discovering this incident, in addition to taking the steps described above, RIC retained cybersecurity experts to learn more about what happened and what information could have been affected. RIC also implemented additional security measures to further harden its environment in an effort to prevent a similar event from occurring in the future. Additionally, RIC has reported the incident to the FBI and will cooperate with any resulting investigation.

Finally, RIC is notifying the affected individuals and providing them with steps they can take to protect their personal information as discussed above. RIC has also established a toll-free call center through TransUnion, a leader in risk mitigation and response, to answer any questions about the incident and address related concerns.

Re: Notice of Data Security Incident

Dear [REDACTED]:

Renaissance Infrastructure Consulting (“RIC”) is writing to inform you of a recent data security incident that involved your personal information. RIC takes the privacy and security of all information within its possession very seriously. You may be receiving this letter because you are a current or former employee of RIC, or a dependent of one. Please read this letter carefully, as it contains important information regarding the incident and resources you can utilize to protect your information, including instructions for enrolling in complimentary credit monitoring and identity theft protection services.

What Happened? We recently determined that some of your personal information was involved in a data security incident. On August 11, 2025 we experienced a network disruption. We immediately took steps to secure our network and engaged cybersecurity experts to conduct an investigation. The investigation determined that an unknown actor accessed and acquired certain data without authorization on or about August 11, 2025. We then performed a review of the impacted data to determine whether it included personal information. On November 5, 2025, we confirmed the scope of the impact and secured information sufficient to effectuate notice. We then took steps to notify you of the incident as quickly as possible. Please note that we have no evidence of misuse or attempted misuse of any involved data.

What Information Was Involved? The information may have involved your name together with your Social Security number, driver's license number, passport number, and health insurance information.

What We Are Doing: As soon as we discovered this incident, we took the steps described above and implemented measures to enhance our network security and minimize the risk of a similar incident occurring in the future. We also notified the Federal Bureau of Investigation and will cooperate with any resulting investigation.

Additionally, we are offering you the opportunity to enroll in complimentary credit monitoring and identity theft protection services, including a \$1,000,000 identity theft insurance policy, at no charge to you. These services provide you with alerts for 12 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any

questions that you might have or in event that you become a victim of fraud. These services are provided through Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

To enroll in the credit monitoring and identity theft protection services at no charge to you, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED]. In order for you to receive the services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age.

What You Can Do: You can follow the recommendations on the following page to help protect your personal information. You can also enroll in the complementary services offered to you through TransUnion by using the enrollment code provided above. TransUnion representatives can help answer questions you may have regarding the incident and the protection of your information.

Additional Steps You Can Take to Further Protect Your Information

Review Your Account Statements and Notify Law Enforcement of Suspicious Activity: As a precautionary measure, we recommend that you remain vigilant by reviewing your account statements and monitoring free credit reports closely for errors and by taking other steps appropriate to protect accounts, including promptly changing passwords. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained for remediation assistance or contact a remediation service provider. You also should promptly report any fraudulent activity or any suspected incidence of identity theft to proper law enforcement authorities, your state attorney general, and/or the Federal Trade Commission (FTC). You should also contact your local law enforcement authorities and file a police report. Obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. Contact information for the FTC is as follows:

Copy of Credit Report: You may obtain a free copy of your credit report from each of the three major credit reporting agencies once every 12 months by visiting <http://www.annualcreditreport.com/>, calling toll-free 877-322-8228, or by completing an Annual Credit Report Request Form and mailing it to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348. You can print this form at <https://www.annualcreditreport.com/cra/requestformfinal.pdf>. You also can contact one of the following three national credit reporting agencies:

Fraud Alerts: There are two kinds of general fraud alerts you can place on your credit report—an initial alert and an extended alert. You may want to consider placing either or both fraud alerts on your credit report. An initial fraud alert is free and will stay on your credit file for at least 90 days. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any accounts in your name. You may have an extended alert placed on your credit report if you have already been a victim of identity theft and provide the appropriate documentary proof. An extended fraud alert is also free and will stay on your credit report for seven years. To place a fraud alert on your credit report, contact any of the three credit reporting agencies identified above. Additional information is available at <http://www.annualcreditreport.com>. Military members may also place an Active Duty Military Fraud Alert on their credit reports while deployed. An Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment.

Credit or Security Freezes: Under U.S. law, you have the right to put a credit freeze, also known as a security freeze, on your credit file, for up to one year at no cost. The freeze will prevent new credit from being opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A security freeze is designed to prevent potential creditors from accessing your credit report without your consent. As a result, using a security freeze may interfere with or delay your ability to obtain credit.

You must separately place a security freeze on your credit file with each credit reporting agency. There is no fee to place or lift a security freeze. For information and instructions on how to place a security freeze, contact any of the credit reporting agencies or the FTC identified above. In order to place a security freeze, you may be required to provide the consumer reporting agency with information that identifies you including your full name, Social Security number, date of birth, current and previous addresses, a copy of your state-issued identification card, and a recent utility bill, bank statement or insurance statement. After receiving your freeze request, each credit bureau will provide you with a unique PIN or password. Keep the PIN or password in a safe place as you will need it if you choose to lift the freeze.

A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or via phone, a credit bureau must lift the credit freeze within an hour. If the request is made by mail then the bureau must lift the freeze no later than three business days after receiving your request.

IRS Identity Protection PIN: You can obtain an identity protection PIN (IP PIN) from the IRS that prevents someone else from filing a tax return using your Social Security number. The IP PIN is known only to you and the IRS and helps the IRS verify your identity when you file your electronic or paper tax return. You also have certain rights under the Fair Credit Reporting Act (FCRA): These rights include the right to know what is in your file; to dispute incomplete or inaccurate information; to have consumer reporting agencies correct or delete inaccurate, incomplete, or unverifiable information. Additional Free Resources: You can obtain information from the consumer reporting agencies, the FTC, or from your respective state attorney general about fraud alerts, security freezes, and steps you can take toward preventing identity theft. You may report suspected identity theft to local law enforcement, including to the FTC or to the attorney general in your state.
