This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Precision Tax Relief, LLC (“PTR”) does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

PTR recently became aware of suspicious activity within its computer network. Upon learning of the suspicious activity, PTR immediately took steps to secure its systems and launched an investigation into the nature and scope of the activity. The investigation determined that an unauthorized actor accessed the PTR network at various times on April 1, 2025, and certain information contained within those systems was viewed or copied by the unauthorized actor. Upon becoming aware of these findings, PTR undertook a comprehensive and time-intensive review of the data at risk to determine what information was potentially affected and to whom that information was related. Those efforts recently completed.

The information that could have been subject to unauthorized access includes name, Social Security number, driver's license number, and financial account information.

Notice to Nebraska Residents

On May 30, 2025, PTR provided written notice of this incident to fifteen (15) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, PTR moved quickly to investigate and respond to the incident, assess the security of PTR systems, and identify potentially affected individuals. Further, PTR notified federal law enforcement regarding the event and is cooperating with its investigation. PTR is also working to implement additional safeguards and training to its employees. PTR is providing access to credit monitoring services for twelve (12) months, through Epiq, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, PTR is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. PTR is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

PTR is providing written notice of this incident to relevant state and federal regulators, as necessary, and to the three (3) major credit reporting agencies, Equifax, Experian, and TransUnion.

Precision Tax Relief, LLC ("PTR") writes to make you aware of an event that may involve some of your personal information. This letter provides you with information about the event, our response, and resources available to help you protect your information, should you feel it appropriate to do so.

What Happened? PTR recently became aware of suspicious activity within our computer network. Upon learning of the suspicious activity, we immediately took steps to secure our systems and launched an investigation into the nature and scope of the activity. The investigation determined that an unauthorized actor accessed the PTR network at various times on April 1, 2025, and certain information contained within those systems was viewed or copied by the unauthorized actor. Upon becoming aware of these findings, we undertook a comprehensive and time-intensive review of the data at risk to determine what information was potentially affected and to whom that information was related. Those efforts recently completed, and PTR is notifying you because the investigation determined that certain information relating to you was contained within the impacted files.

What Information Was Involved? The following types of information related to you were found in the impacted files: your <<Breached Elements>>. At this time, PTR is not aware of your information being used to commit identity theft or fraud in relation to this incident.

What We Are Doing. We take this event seriously, and the confidentiality, privacy, and security of information in our care is among our highest priorities. Upon learning of this event, we moved quickly to investigate and respond, assess the security of our network, and notify affected individuals. Additionally, we notified federal law enforcement of the event and are cooperating with their investigation. As part of our ongoing commitment to information security, we are reviewing existing security policies and dedicating significant resources to implement additional cybersecurity measures to further protect against similar events moving forward. We are also notifying impacted individuals, including you, so they may take steps to best protect their information, should they feel it is appropriate to do so.

As an added precaution, we are offering you immediate access to complementary credit monitoring and identity theft protection services for <<CM Duration>> through Epiq. You can find information on how to enroll in these services in the enclosed *STEPS YOU CAN TAKE TO HELP PROTECT YOUR INFORMATION*. We encourage you to enroll in these services as we are not able to do so on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next twelve

(12) to twenty-four (24) months. You can review the enclosed *STEPS YOU CAN TAKE TO HELP PROTECT YOUR INFORMATION* to learn helpful tips on steps you can take to protect against possible information misuse, should you feel it appropriate to do so. You may also enroll in the complimentary credit monitoring services we are offering to you.

Privacy Solutions ID provides credit monitoring through Equifax, credit report and score access, \$1 million identity theft insurance with \$0 deductible, ID Restoration services, and dark web monitoring. See below for more details.

Credit Monitoring with Alerts

Monitors your credit file(s) for key changes, with alerts such as credit inquiries, new accounts, and public records.

1-Bureau Credit Score and Report¹

Annual 1-Bureau VantageScore and 1-Bureau Credit Report

SSN Monitoring (High Risk Transaction Monitoring, Real-Time Authentication Alerts, Real-Time Inquiry Alerts)

Provides up to \$1,000,000 (\$0 deductible) Unauthorized Electronic Funds Transfer Reimbursement. This aids in the recovery of stolen funds resulting from fraudulent activity - occurrence-based.

Personal Info Protection

Helps users find their exposed personal information on the surface web—specifically on people search sites and data brokers – so that the user can opt out/remove it. Helps protect members from ID theft, robo calls, stalkers, and other privacy risks.

¹ The credit scores provided are based on the VantageScore 3.0 model. For three-bureau VantageScore credit scores, data from Equifax®, Experian®, and TransUnion® are used respectively. Any one-bureau VantageScore uses Equifax data. Third parties use many different types of credit scores and are likely to use a different type of credit score to assess your creditworthiness. Credit monitoring from Experian and TransUnion will take several days to begin.

File Your Tax Return

We encourage you to file your tax return as soon as possible, if you have not already done so. You can also contact the Internal Revenue Service (“IRS”) at <https://www.irs.gov/Individuals/Identity-Protection> for helpful information and guidance on steps you can take to prevent a fraudulent tax return from being filed in your name and what to do if you become the victim of such fraud. The IRS has many security measures in place to verify the accuracy of tax returns and the validity of Social Security numbers or individual taxpayer identification numbers submitted.

- If you receive a notice from the IRS that leads you to believe someone may have used your Social Security number fraudulently, please notify the IRS immediately by responding to the contact at the number printed on the notice or letter.
- If you're an actual or potential victim of identity theft and would like the IRS to mark your account to identify any questionable activity, please complete Form 14039, Identity Theft Affidavit. See the "Instructions for Submitting this Form" in Form 14039, for information on submitting it by mail or fax.
- You may also contact the IRS for specialized assistance at 1 (800) 908-4490. These IRS employees are available to answer questions about identity theft and resolve any tax account issues that resulted from identity theft.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one (1) free credit report annually from each of the three (3) major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit <http://www.annualcreditreport.com> or call, toll-free, 1 (877) 322-8228. Consumers may also directly contact the three (3) major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one (1) year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven (7) years. Should consumers wish to place a fraud alert, please contact any of the three (3) major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two (2) to five (5) years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and

7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect their personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement, the relevant state Attorney General, and the Federal Trade Commission. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
