By providing this notice, Retail Therapy does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

Retail Therapy has been actively investigating a cyber security event in which an unauthorized third party gained access to certain systems within its network. The investigation determined that certain information on Retail Therapy systems may have been viewed or taken without authorization between November 20, 2025, and December 11, 2025. Retail Therapy reviewed the data that may be involved to determine whether it contained sensitive information and are notifying individuals of this event.

The information that could have been subject to unauthorized access may include name, date of birth, Social Security number, driver license number, state identification number, and passport number.

Notice to Nebraska Resident

On or about April 14, 2026, Retail Therapy provided written notice of this incident to one (1) Nebraska resident. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, Retail Therapy moved quickly to investigate and respond to the incident, assess the security of Retail Therapy systems, and identify potentially affected individuals. Further, Retail Therapy notified federal law enforcement regarding the event. Retail Therapy is also working to implement additional safeguards and training to its employees. Retail Therapy is providing access to credit monitoring services for twelve (12) months, through TransUnion, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Retail Therapy is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Retail Therapy is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Retail Therapy is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

NOTICE OF DATA BREACH

Retail Therapy LLC (“Retail Therapy”) writes to notify you of a recent event that involved some of your information. We are providing you with information about the event, our response to it, and resources available to you to help protect your information, should you feel it appropriate to do so.

What Happened? Retail Therapy has been actively investigating a cyber security event in which an unauthorized third party gained access to certain systems within our network. The investigation determined that certain information on our systems may have been viewed or taken without authorization between November 20, 2025, and December 11, 2025. We reviewed the data that may be involved to determine whether it contained sensitive information and are notifying individuals of this event.

What Information Was Involved? The personal information stored on the systems accessible to the unauthorized actor may include your name, date of birth, Social Security number, driver's license number, government issued ID, and passport number.

What We Are Doing. We take this event and the security of personal information in our care seriously. Upon becoming aware of the event, we took steps to secure the network, investigate the activity, and determine the scope of impacted information.

As an added precaution, we are providing you with 12 months of complimentary access to credit monitoring and identity restoration services through TransUnion as well as guidance on how to better protect your information. Enrollment information is contained in the attached *Steps You Can Take to Protect Personal Information*.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity. You may also review the information contained in the attached *Steps You Can Take to Protect Personal Information*. There, you will find more information on the credit monitoring and identity restoration services we are making available to you. We encourage you to activate these services as we are not able to act on your behalf.

Steps You Can Take To Protect Personal Information

Enroll in Monitoring Services

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services:

. In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
