This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, S.V.D.P. Management, Inc. (“SVDP”) does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On July 29, 2025, SVDP determined that certain personal information may have been subject to unauthorized access or acquisition between September 26, 2024 and October 12, 2024. As part of its response to this event, SVDP initiated an investigation into the nature and scope of the event. SVDP also undertook a detailed and time intensive review of the information involved. In an abundance of caution, SVDP is notifying individuals whose personal information may have been involved in this event.

The information that could have been subject to unauthorized access includes name, Social Security number and financial account information.

Notice to Nebraska Residents

On or about August 29, 2025, SVDP provided written notice of this incident to thirty-two (32) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, SVDP moved quickly to investigate and respond to the incident, assess the security of SVDP systems, and identify potentially affected individuals. Further, SVDP notified federal law enforcement regarding the event. SVDP is also working to implement additional safeguards and training to its employees. SVDP is providing access to credit monitoring services for twelve (12) months, through IDX, to individuals whose personal information was potentially involved in this incident, at no cost to these individuals.

Additionally, SVDP is providing impacted individuals with guidance on how to better protect against identity theft and fraud. SVDP is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

SVDP is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

S.V.D.P. Management, Inc. ("SVDP") writes to notify you of an event that may involve some of your personal information. We are providing you with notice of the event, steps we have taken in response, and resources available to help you better protect your information, should you feel it is appropriate to do so.

What Happened? On July 29, 2025, we determined that certain personal information may have been subject to unauthorized access or acquisition between September 26, 2024 and October 12, 2024. As part of our response to this event, SVDP initiated an investigation into the nature and scope of the event. We also undertook a detailed and time intensive review of the information involved. In an abundance of caution, we are notifying individuals whose personal information may have been involved in this event.

What Information Was Involved? The information involved includes your name and <<Variable Text 3: Data Elements>>. We have no evidence that identity theft or fraud has occurred as a result of this event.

What We Are Doing? We take this event and the security of personal information in our care seriously. Accordingly, we have strict security measures in place to protect information in our care. Upon discovering the network disruption, we took steps to secure the network, investigate the activity, and determine the scope of impacted information. Our immediate response to this event also included prompt notification to federal law enforcement authorities.

As an added precaution, we are providing you with <<twelve (12)/ twenty-four (24)]>> months of complimentary access to credit monitoring and identity restoration services through IDX, as well as guidance on how to better protect your information. Although we are covering the cost of these services, due to privacy restrictions, you will need to complete the activation process yourself using the enrollment instructions included within the enclosure to this letter.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Further, please review the enclosed *Steps You Can Take to Protect Your Personal Information* section of this letter for additional information. We also encourage you to enroll in the complimentary credit monitoring services we are offering you.

STEPS YOU CAN TAKE TO HELP PROTECT YOUR PERSONAL INFORMATION

Enroll in Monitoring Services

1. Website and Enrollment. Scan the QR image or go to <https://response.idx.us/svdp> and follow the instructions for enrollment using your Enrollment Code provided at the top of the letter.

2. Activate the credit monitoring provided as part of your IDX identity protection membership. The monitoring included in the membership must be activated to be effective. Note: You must have established credit and access to a computer and the internet to use this service. If you need assistance, IDX will be able to assist you.

3. Telephone. Contact IDX at 1-833-353-4184 to gain additional information about this event and speak with knowledgeable representatives about the appropriate steps to take to protect your credit identity.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
