This notice may be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Michigan Sugar Company (“MSC”) does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On August 14, 2025, MSC became aware of suspicious activity in its network in which an unauthorized third party gained access to certain systems in its network. Upon becoming aware of this event, MSC promptly launched an investigation, with the assistance of third-party cybersecurity specialists, to determine the nature and scope of the event. The investigation determined that there may have been unauthorized access to certain MSC systems on August 14, 2025, that may have resulted in the unauthorized access and acquisition of certain data. MSC conducted a thorough and comprehensive review to determine what information was accessible and to whom such information relates. On December 17, 2025, MSC confirmed that the files involved may contain personal information.

The information that could have been subject to unauthorized access includes name and Social Security number.

Notice to Nebraska Residents

On or about January 30, 2026, MSC provided written notice of this incident to approximately two (2) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

MSC has undertaken extensive efforts to investigate this incident and determine what information may be affected. Upon discovering the event, MSC moved quickly to investigate and respond to the incident, assess the security of MSC systems, and identify potentially affected individuals. MSC is also working to implement additional safeguards and training to its employees. MSC is providing access to credit monitoring services for one (1) year, through IDX, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, MSC is providing impacted individuals with guidance on how to better protect against identity theft and fraud. MSC is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

MSC is providing written notice of this incident to relevant state regulators, as necessary.

This notice provides information about the event, our response, and resources available to you to help protect your information from possible misuse, should you feel it is appropriate to do so.

What Happened? On August 14, 2025, we became aware of suspicious activity in our network in which an unauthorized third party gained access to certain systems in our network. Upon becoming aware of this event, MSC promptly launched an investigation, with the assistance of third-party cybersecurity specialists, to determine the nature and scope of the event. The investigation determined that there may have been unauthorized access to certain MSC systems on August 14, 2025, that may have resulted in the unauthorized access and acquisition of certain data. We conducted a thorough and comprehensive review to determine what information was accessible and to whom such information relates. On December 17, 2025, we confirmed that the files involved may contain personal information.

What Information Was Involved? The investigation determined that the information involved may include your name and <<Variable Text: Data Elements>>.

What We Are Doing. The confidentiality, privacy, and security of information in our care are among our highest priorities. Upon becoming aware of the event, we moved to investigate and respond, assess the security of our systems, and notify potentially affected individuals. We are also providing guidance on best practices to protect personal information in the *Steps You Can Take to Protect Personal Information*. As an added precaution, we are offering credit monitoring and identity restoration services through IDX for <<12/24>> months, at no cost to you.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Further, please review the enclosed *Steps You Can Take to Protect Personal Information* section of this letter for additional information. We also encourage you to enroll in the complimentary credit monitoring services we are offering you.

STEPS YOU CAN TAKE TO PROTECT PERSONAL INFORMATION

Enroll in Monitoring Services

1. Website and Enrollment. Scan the QR image or go to <https://app.idx.us/account-creation/protect> and follow the instructions for enrollment using your Enrollment Code provided at the top of the letter. Please note the deadline to enroll is April 30, 2026.

2. Activate the credit monitoring provided as part of your IDX identity protection membership. The monitoring included in the membership must be activated to be effective. Note: You must have established credit and access to a computer and the internet to use this service. If you need assistance, IDX will be able to assist you.

3. Telephone. Contact IDX at 1-888-201-1802 to gain additional information about this event and speak with knowledgeable representatives about the appropriate steps to take to protect your credit identity.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
