Carlson Building Maintenance, Inc. (“Carlson”) recently concluded an investigation into an incident involving unauthorized access to an internal email account between September 30, 2024, and October 7, 2024. Upon learning of the incident, Carlson took measures to secure its email environment and launched an investigation. Carlson began reviewing the emails and attachments in the account, and the review process generated a preliminary list of individuals whose information was involved. Carlson then worked to review the list and supplement it with addresses and other information to be able to identify individuals to notify. Carlson’s review confirmed on January 18, 2024, that the files contained the names and one or more of the following for 173 Nebraska residents: Social Security number and/or driver’s license number or state identification number.

On February 26, 2025, Carlson sent notifications via U.S. First-Class mail to the Nebraska residents. A copy of the notification is enclosed. Carlson is offering the notice recipients one year of complimentary credit monitoring, fraud consultation, and identity theft restoration services through Equifax. Carlson has also established a toll-free call center to answer any questions notified individuals may have.

Carlson Building Maintenance, Inc. recognizes the importance of protecting the information we maintain. We are writing to inform you of a security incident that involved some of your information. This letter explains the incident, measures we have taken, and some additional steps you may consider taking in response.

We recently concluded an investigation into an incident involving unauthorized access to an internal email account <<Variable Data 1>>. Upon learning of the incident, we took measures to secure our email environment and launched an investigation. We began reviewing the emails and attachments in the account, and the review process generated a preliminary list of individuals whose information was involved. We then worked to review the list and supplement it with addresses and other information to be able to identify individuals to notify. Our review confirmed <<Variable Data 2>> that the files contained your name, Social Security number, and one or more of the following: driver's license or state identification number, Alien Registration Number, <<Variable Data 3>> date of birth, and/or biometric data.

We arranged for you to receive a complimentary <<CM Duration>> membership of identity monitoring services through Equifax. These services are completely free to you, and enrolling in them will not hurt your credit score. For more information on additional steps that you can take and instructions on how to activate your complimentary membership, please review the pages that follow this letter.

ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. To order your annual free credit report, please visit www.annualcreditreport.com or call toll free at 1-877-322-8228. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
