This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Express Services Inc. (“Express”) does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On December 5, 2024, Express became aware of potential unauthorized access into a single network storage location. Express quickly began an investigation and confirmed access between November 16 and November 18, 2024. Express identified a legacy database at risk and undertook a detailed review of the relevant database to determine what information was present and to whom it relates. This review was completed on January 23, 2025, and Express worked as quickly as possible thereafter to provide this notice to potentially impacted individuals.

The information that could have been subject to unauthorized access includes name, and Social Security number.

Notice to Nebraska Resident

On or about February 7, 2025, Express provided written notice of this incident to one (1) Nebraska resident. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, Express investigated and responded to the incident, assessed the security of Express systems, and identified potentially affected individuals. Express is also working to implement additional safeguards and training to its employees. Express is providing access to credit monitoring services for one (1) year, through Epiq, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Express is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Express is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Express is providing written notice of this incident to relevant state regulators, as necessary.

NOTICE OF DATA BREACH

Express Services Inc, (“Express”) is writing to inform you of an event that may involve some of your information. This letter provides you with information about the event, our response, and steps you may take to help protect your information, should you feel it is appropriate to do so.

What Happened? On December 5, 2024, Express became aware of potential unauthorized access into a single network storage location. Express quickly began an investigation and confirmed access between November 16 and November 18, 2024. Express identified a legacy database at risk and undertook a detailed review of the relevant database to determine what information was present and to whom it relates. This review was completed on January 23, 2025, and Express worked as quickly as possible thereafter to provide this notice to potentially impacted individuals.

What Information Was Involved? The information potentially affected includes the following information: name and Social Security number. At this time, Express has no evidence of fraud or misuse of your information.

What We Are Doing. In response to this event, Express worked quickly to begin a comprehensive investigation and review its network infrastructure. We are also evaluating policies, procedures, and technical security measures and implementing additional safeguards as appropriate to further secure the information in our systems.

As an added precaution, Express is offering you access to <<CM Duration>> months of complimentary credit monitoring and identity protection services. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
