By providing this notice, IMT Insurance does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On July 24, 2024, IMT Insurance was alerted to suspicious activity in certain employee email accounts. IMT Insurance immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. The investigation determined that an unauthorized actor gained access to the email accounts of several IMT Insurance employees. Thereafter, IMT Insurance undertook a comprehensive review of all the files potentially impacted to determine what information was present and to whom it related. On January 8, 2025, IMT Insurance finalized this review and determined that information related to Nebraska residents could be affected. The information potentially impacted by this incident includes name, Social Security number, driver's license number, and medical information.

Notice to Nebraska Residents

On February 13, 2025, IMT Insurance provided written notice of this incident to fourteen (14) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, IMT Insurance moved quickly to investigate, assess the security of its systems, and identify potentially affected individuals. IMT Insurance is providing individuals whose personal information was potentially affected by this incident with access to credit monitoring services for two (2) years through Experian at no cost to the individuals.

Additionally, IMT Insurance is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. IMT Insurance is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, information on protecting against tax fraud, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. IMT Insurance is also notifying state regulators, as necessary.

IMT Insurance is providing written notice of this incident to relevant state regulators, as necessary.

IMT Insurance Company (“IMT Insurance”) is writing to notify you of an incident that may have impacted your information. This letter provides details of the incident, our response, and steps you may take to help protect your information should you feel it’s appropriate to do so.

What Happened? On July 24, 2024, IMT Insurance was alerted to suspicious activity in certain employee email accounts. IMT Insurance immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. The investigation determined that an unauthorized actor gained access to the email accounts of several IMT Insurance employees. Thereafter, IMT Insurance undertook a comprehensive review of these email accounts to assess what information was contained therein and to whom it related. On January 8, 2025, IMT Insurance finalized this review and determined that information related to you could be affected.

What Information Was Involved? The information potentially impacted by this incident includes your name and [data elements].

What We Are Doing. IMT Insurance takes the confidentiality, privacy, and security of information in its care very seriously. Upon discovering the event, IMT Insurance conducted a diligent investigation to confirm the full nature and scope, took prompt steps to ensure the security of its email tenant, and conducted a comprehensive review of the information potentially affected. IMT Insurance also enhanced its existing security protocols.

As an added precaution, IMT Insurance is providing you access to credit monitoring services for 24 months at no cost to you through Experian. Information regarding these services and instructions on how to activate them, can be found in the enclosed *Steps You Can Take to Help Protect Your Personal Information*. Please note that you must complete the enrollment process as we are not permitted to enroll you in these services.

What You Can Do. IMT Insurance encourages you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and explanation of benefits and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 to 24 months. IMT Insurance also encourages you to enroll in the complimentary services being offered.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information
