By providing this notice, Tuggle Duggins P.A. (“Tuggle Duggins”) does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

In October 2024, Tuggle Duggins identified suspicious activity within certain computer systems. Tuggle Duggins quickly took steps to secure its network and launched an investigation into the nature and scope of the activity. Through this investigation, Tuggle Duggins determined that certain computer systems were subject to unauthorized access and files were copied from its network on October 1, 2024. As a result, Tuggle Duggins undertook a comprehensive review of the involved files in order to identify whether they contained any sensitive information and to whom this information relates. Once the review was completed, on October 22, 2025, Tuggle Duggins began notifying impacted individuals and clients. Although the information varies for each individual, the information that could have been subject to unauthorized access includes name and Social Security number. Tuggle Duggins coordinated notification with clients and is providing notice to individuals and regulators, as directed, on its client’s behalf.

Notice to Nebraska Residents

On February 6, 2026, Tuggle Duggins provided written notice of this incident to individuals, including fifteen (15) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, Tuggle Duggins moved quickly to investigate and respond to the incident, assess the security of Tuggle Duggins systems, and identify potentially affected individuals. Further, Tuggle Duggins notified federal law enforcement regarding the event. Tuggle Duggins also implemented additional safeguards and training for its employees. Tuggle Duggins is providing access to credit monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Tuggle Duggins is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud, including information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. Tuggle Duggins is also providing written notice of this incident to relevant state regulators, as necessary.

NOTICE OF SECURITY INCIDENT

Tuggle Duggins P.A. ("Tuggle Duggins") is writing to inform you of a recent event that may affect some of your information. Tuggle Duggins is a law firm that obtained your information in connection with the provision of legal services. We are providing you with information about the event, our response, and additional measures you can take to help protect your information, should you feel it appropriate to do so.

What Happened? In October 2024, we identified suspicious activity within certain computer systems. We quickly took steps to secure our network and launched an investigation into the nature and scope of the activity. Through this investigation, we determined that certain computer systems were subject to unauthorized access and files were copied from our network on October 1, 2024. As a result, we undertook a comprehensive review of the involved files in order to identify whether they contained any sensitive information and to whom this information relates.

What Information Was Involved? Our review and investigation was recently completed and we are notifying clients and potentially impacted individuals. We are notifying you because your name and Health Related Information and Social Security Number were identified during the review. Please note, Tuggle Duggins is not aware of any identity theft or fraud as a result of this incident.

What We Are Doing. The confidentiality, privacy, and security of information in our care is among our highest priorities. In response to the event, we quickly took steps to secure our network and commenced an investigation. We reviewed existing security policies and implemented additional cybersecurity measures to further protect against similar events moving forward. As an added precaution, we are offering you immediate access to complimentary credit monitoring and identity theft protection services for 12 months through Experian. You can find information on how to enroll in these services in the enclosed *STEPS YOU CAN TAKE TO HELP PROTECT PERSONAL INFORMATION*.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Please also review the information contained in the enclosed *STEPS YOU CAN TAKE TO HELP PROTECT PERSONAL INFORMATION*. We also encourage you to enroll in the complimentary credit monitoring.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information
