This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Lautrec, Ltd. (“Lautrec”) does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On September 21, 2025, Lautrec became aware of suspicious activity within their network. In response, Lautrec promptly took steps to secure their network and initiated a comprehensive investigation to determine the full nature and scope of the activity with the assistance of third-party forensic specialists. The investigation determined that on September 20, 2025, certain files within Lautrec’s network were accessed and copied without authorization. Lautrec identified the affected files and engaged a data review vendor to complete a time-intensive and comprehensive review of the files to identify personal information contained therein and to whom the information relates. This process was recently completed.

The information related to the Nebraska resident includes: name and Social Security number.

Notice to Nebraska Resident

On May 8, 2026, Lautrec provided written notice of this event to approximately one (1) Nebraska resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon learning of the event, Lautrec promptly commenced an investigation and response that included confirming the security of their network, investigating to determine the information that was impacted, and reviewing the contents of relevant data for sensitive information. As part of Lautrec’s ongoing commitment to the privacy of information in their care, they are implementing additional security measures to further protect against similar events occurring in the future. Lautrec also reported this event to federal law enforcement. Although Lautrec is not aware of any identity theft or fraud as a result of this event, in an abundance of caution, Lautrec is providing individuals with access to complimentary credit monitoring and identity theft protection services for twelve (12) months, through TransUnion.

Additionally, Lautrec is providing individuals with guidance on how to better protect against identity theft and fraud, including information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. Lautrec is providing written notice of this event to relevant privacy regulators and to the major U.S. credit reporting agencies.

NOTICE OF SECURITY INCIDENT

Lautrec, Ltd. ("Lautrec") is writing to inform you of an event that impacted the privacy of some of your personal information. Although at this time there is no indication that your information has been used to commit identity theft or fraud in relation to this event, we are providing you with information about the event, our response, and additional measures you can take to help protect your information, should you feel it appropriate to do so.

What Happened? On September 21, 2025, Lautrec became aware of suspicious activity within our network. In response, we promptly took steps to secure our network and initiated a comprehensive investigation to determine the full nature and scope of the activity with the assistance of third-party forensic specialists. The investigation determined that on September 20, 2025, certain files within Lautrec's network were accessed and copied without authorization. Lautrec identified the affected files and engaged a data review vendor to complete a time-intensive and comprehensive review of the files to identify personal information contained therein and to whom the information relates. This process was recently completed, and we are notifying you because the review determined certain information related to you was contained within the affected files.

What Information Was Involved? The review determined your name and the following types of information related to you were present in the affected files at the time of the event: [REDACTED]

What We Are Doing. The confidentiality, privacy, and security of personal information within our care are among Lautrec's highest priorities. Upon learning of the event, we promptly commenced an investigation and response that included confirming the security of our network, investigating to determine the information that was impacted, and reviewing the contents of relevant data for sensitive information. As part of our ongoing commitment to the privacy of information in our care, we are implementing additional security measures to further protect against similar incidents occurring in the future. We also reported this event to federal law enforcement.

As an added precaution, we are offering you immediate access to complimentary credit monitoring and identity theft protection services for twelve (12) months through Cyberscout, a TransUnion company. You can find information on how to enroll in these services in the enclosed *Steps You Can Take To Help Protect Personal Information*. We encourage you to consider enrolling in these services as we are not able to do so on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You can review the enclosed *Steps You Can Take To Help Protect Personal Information* to learn helpful tips on steps you can take to protect against possible information misuse, should you feel it appropriate to do so. You may also enroll in the complimentary credit monitoring services we are offering to you.

Steps You Can Take To Help Protect Personal Information

Enroll in Monitoring Services

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED] In order for you to receive the monitoring services described above, you must enroll within ninety (90) days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under eighteen (18) years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one (1) free credit report annually from each of the three (3) major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit <http://www.annualcreditreport.com> or call, toll-free, 1 (877) 322-8228. Consumers may also directly contact the three (3) major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one (1) year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven (7) years. Should consumers wish to place a fraud alert, please contact any of the three (3) major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two (2) to five (5) years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect their personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement, the relevant state Attorney General, and the Federal Trade Commission. This notice has not been delayed by law enforcement.
