By providing this notice, SA Bendheim, Co., Inc. (“Bendheim”) located at 82 Totowa Road, Wayne, NJ 07470, does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or around November 8, 2024, Bendheim discovered suspicious activity on certain network systems and determined we were experiencing a cyber incident. Bendheim immediately launched an investigation and worked with forensic specialists to determine the full nature and scope of the event. Based on the investigation, we determined that certain information was copied from Bendheim’s system on or around November 7th and 8th, 2024. Bendheim then undertook a thorough and comprehensive review of the information impacted and recently concluded this review.

The information impacted included name and Social Security number.

Notice to Nebraska Resident

On or about October 13, 2025, Bendheim provided written notice of this incident to one (1) Nebraska resident. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, Bendheim moved quickly to investigate and respond to the incident, assess the security of Bendheim systems, and identify potentially affected individuals. Further, Bendheim is also working to implement additional safeguards and training to its employees. Bendheim is providing access to credit monitoring services for twelve (12) months through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Bendheim is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Bendheim is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

The privacy and security of the personal information we maintain is of the utmost importance to SA Bendheim, Co., Inc. ("Bendheim"). We are writing to notify you of an incident that affects the privacy of some of your personal information. We take this incident very seriously and are providing details of the incident and the resources available to you to help protect your information from possible misuse, should you feel it is appropriate to do so.

What Happened? On or around November 8, 2024, Bendheim discovered suspicious activity on certain network systems and determined we were experiencing a cyber incident. We immediately launched an investigation and worked with forensic specialists to determine the full nature and scope of the event. Based on the investigation, we determined that certain information was copied from the systems on or around November 7th and 8th, 2024. We then undertook a very thorough and comprehensive review of the impacted data, and recently determined that information related to you was affected.

What Information Was Involved? The type of information related to you that was impacted by this incident includes your name and the following: [Extra1].

What We Are Doing. We take the confidentiality, privacy, and security of information in our case seriously. Upon discovery, we secured our systems and launched an investigation with third party specialists to determine the nature and scope of the potentially affected data. As an added precaution, we are also offering you complimentary access to [Extra3] months of credit monitoring and identity theft restoration services through Experian. Please review the instructions in the attached *Steps You Can Take to Help Protect Your Personal Information* for additional information on these services.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements, enrolling in the provided credit monitoring, and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 to 24 months. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
