We represent IMA Diligence Services, LLC (“IMA Diligence”) located at 430 East Douglas Avenue, Suite 400, Wichita, KS 67202, and are writing to notify your office of an incident that may affect the security of certain personal information relating to three hundred ninety-two (392) Nebraska residents. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, IMA Diligence does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about December 16, 2025, IMA Diligence became aware of suspicious activity on a legacy server hosted by a third-party, which is now decommissioned and no longer in use. IMA Diligence immediately engaged third-party cybersecurity specialists to conduct an investigation with the goal of determining the full nature and scope of this incident. It was determined that an unauthorized actor had accessed this file server and acquired certain files. Therefore, IMA Diligence conducted a comprehensive review to identify what information was impacted and the individuals to whom the information relates, in order to notify potentially impacted individuals.

The information that could have been subject to unauthorized access includes name, driver's license number, Social Security number, and financial account information.

Notice to Nebraska Residents

On or about May 29, 2026, IMA Diligence provided written notice of this incident to three hundred ninety-two (392) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, IMA Diligence moved quickly to investigate and respond to the incident, assess the security of IMA Diligence systems, and identify potentially affected individuals. Further, IMA Diligence notified federal law enforcement regarding the event. IMA Diligence is also working to implement additional safeguards and training to its employees. IMA Diligence is providing access to credit monitoring services for twelve (12) months, through TransUnion, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, IMA Diligence is providing impacted individuals with guidance on how to better protect against identity theft and fraud. IMA Diligence is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

IMA Diligence is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

Dear

IMA Diligence Services, LLC (“IMA Diligence”) writes to inform you of an incident that may affect the security of your personal information. IMA Diligence is in possession of your data in connection with the provision of professional services requiring the analysis of data shared with us. We are not aware of any misuse of your information, but out of an abundance of caution, we are writing to let you know what happened, what we have done, and what you can do to protect your personal information, should you feel it is appropriate to do so.

What Happened? On or about December 16, 2025, IMA Diligence learned that certain files located on a legacy server managed by a third-party, which is now decommissioned and no longer in use, were inaccessible. IMA Diligence immediately engaged third-party cybersecurity specialists to conduct an investigation with the goal of determining the full nature and scope of this incident. It was determined that an unauthorized actor had accessed this file server between December 8, 2025 and December 16, 2025, and acquired certain files. Therefore, IMA Diligence conducted a comprehensive review to identify what information was impacted and the individuals to whom the information relates, in order to notify potentially impacted individuals.

What Information Was Involved? The detailed and time intensive review of the affected files identified that the information contained in these files included your name and:

What We Are Doing. Upon discovery, we notified law enforcement and promptly commenced an investigation to confirm the nature and scope of this incident. This investigation and response included confirming the security of our systems, reviewing the contents of relevant data for sensitive information, and notifying potentially impacted individuals. As part of our ongoing commitment to the privacy of information, we continue to review our policies, procedures and processes related to the storage and access of personal information to reduce the likelihood of a similar future event. We will notify applicable regulatory authorities where necessary.

As an added precaution, we are providing you with twelve (12) months of complimentary access to credit monitoring and identity restoration services through Cyberscout, a TransUnion company, at no cost to you. Instructions on how to activate these services are included in the attached *Steps You Can Take to Help Protect Personal Information*. We encourage you to enroll in these services as we are unable to do so on your behalf.

What You Can Do. We additionally encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 to 24 months. You can find out more about how to safeguard your information in the enclosed *Steps You Can Take to Help Protect Your Personal Information*. There, you will find additional information about the complimentary credit monitoring and identity restoration services we are offering and how to enroll.

STEPS YOU CAN TAKE TO HELP PROTECT YOUR PERSONAL INFORMATION

Enroll in Monitoring Services

In response to the incident, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for twelve (12) months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in the event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services:

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state attorney general. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state attorney general. This notice has not been delayed by law enforcement.

For New Mexico residents, consumers have rights pursuant to the Fair Credit Reporting Act, such as the right to be told if information in their credit file has been used against them, the right to know what is in their credit file, the right to ask for their credit score, and the right to dispute incomplete or inaccurate information. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
