By providing this notice, KCAC does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On April 29, 2025, KCAC identified suspicious activity on certain computer systems. In response, KCAC promptly isolated the affected systems and launched an investigation into the nature and scope of the event. The investigation determined that an unauthorized actor accessed certain systems between March 27, 2025 and April 29, 2025 and copied certain files from those systems during that period. Following the investigation, KCAC conducted a thorough review of the files involved to determine the contents of those files and to whom they relate. The investigation determined that the information that could have been subject to unauthorized access includes name and Social Security number.

Notice to Nebraska Residents

On January 6, 2025, KCAC provided written notice of this incident to three (3) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, KCAC moved quickly to investigate and respond to the incident, assess the security of KCAC systems, and identify potentially affected individuals. Further, KCAC notified federal law enforcement regarding the event. KCAC is also working to implement additional safeguards and training to its employees. KCAC is providing access to credit monitoring services for 12 months through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, KCAC is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. KCAC is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, information on protecting against tax fraud, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

KCAC is providing written notice of this incident to relevant state regulators, as necessary.

KCAC Aviation (“KCAC”) writes to inform you of an event that may affect some of your information. This notice provides you with additional information about the incident, our response, and steps you can take to further protect your information should you determine it is appropriate to do so.

What Happened? On April 29, 2025, KCAC identified suspicious activity on certain computer systems. In response, we promptly isolated the affected systems and launched an investigation into the nature and scope of the event. Our investigation determined that an unauthorized actor accessed certain systems between March 27, 2025 and April 29, 2025 and copied certain files from those systems during that period. Following our investigation, we conducted a thorough review of the files involved to determine the contents of those files and to whom they relate.

What Information Was Involved? Our review determined that your name and [Extra1] were included in the affected files. Please note that we are not aware of any fraud or misuse of information related to this event.

What We Are Doing. KCAC takes the security of information seriously. Upon learning of this incident, we promptly took steps to secure our systems and launched an investigation into the nature and scope of the incident. As part of our ongoing commitment to information privacy, we are reviewing and enhancing our already robust security measures to further protect the information in our care.

As an added precaution, we are offering you immediate access to credit monitoring and identity theft protection services for [Extra2] at no cost to you, through Experian. We encourage you to enroll in these services as we are unable to do so on your behalf. The deadline to enroll is April 30, 2026.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. In addition, you can enroll in the free credit monitoring and identity theft protection services that we are providing through Experian. Please note, you must enroll by April 30, 2026 to take advantage of these services. You can also review the enclosed *Steps You Can Take to Help Protect Your Information* for enrollment instructions and to learn helpful tips on steps you can take to protect against possible information misuse, should you feel it is appropriate to do so.

Enroll in Monitoring Services

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
